This election:

At this moment, you are being asked to vote on the 6 further voting members, to be elected for their skills, contacts and experience in representing VCS organisations under the six thematic headings of: Children and Young People, Healthy Communities, Stronger Communities, Safer Communities, Prosperous Communities and Safeguarding (Adult & Children).

Constituted organisations operating in Solihull's VCS are entitled to vote. You have one vote per organisation and you should ensure you have the agreement of your organisation to vote on your behalf.

The 6 candidates polling the most votes and covering all 6 thematic areas between them will be duly elected to the VCS RG. The full results of voting can be made available on request. (Please note, this may mean that a candidate receiving fewer votes may be elected in preference to a candidate receiving more votes, if the top 6 candidates do not cover all thematic areas between them).
